F/029/19 Finance

- a. To receive and resolve the financial report and accounts for payments. Proposed Cllr M Bailey, second Cllr A Rayment. Carried.

- c. Crowle Agricultural Show grant. Council discussed the funding for this and agreed that local events like this should be embraced and supported by the Council and suggested that £2k be made available. The RFO confirmed that this was available. Proposed Cllr M Bailey, second Cllr N Arrand and carried.
- d. Council connfirmed that the Cemeteries/Burials monies (after expenses) should be held in as 'earmarked' in the account for Cemetery business; maintenance/costs etc. Proposed Cllr N Arrand, second Cllr M Bailey. Carried.

F/030/19 Paupers Drain Newbigg

Cllr Ramsden explained that dredging from the Western Boundary is causing loss of land on the Eastern bank of properties along Newbigg. This has been passed previously to the Internal Water Board (IWB) and gone unactioned. Cllr Ramsden believes that this Council should write to the IWB requesting that they site visit and inspect with a view to potentially piling remedial work asap. Cllr I Mason will speak to Mr Andrew Magill, Head of Drainage Board and TC is write a letter to him.

F/031/19 Keep Me Rural Grant

Very little information was known about the group's request other than it is to support a potential legal case. TC is to speak with Vin Clark, KMR and ascertain further information and bring back to March Business meeting.
