F/062/20 Clerks Report

Complaints received:

- a. Gulley flooding concerns on Eastoft Road. Cllr J Reed will take this matter to the flooding board for discussion along with other gulley concerns within the region.
- b. Speeding on Johnsons Lane. The resident is to be directed to report all cases directly to the police for action. This Council will direct this matter back to highways for the Enforcement Dept. as soon as full service is functioning.

The Town Clerk is to respond to both residents in writing.

F/063/20 Ward Report

- a. Waste Collections. NLC will be advertising a new scheme as soon as possible regarding the waste system. Compost bins will be issued free of charge to those residents that opt to continue composting brown bin waste. This service is also to be reintroduced as soon as staffing issues are resolved.
- b. With the re-opening of some facilities and services, NLC staff, previously used to operate call centres will return to work. The volunteers not called forward may now be called to fill in the gaps of returning staff. The priority remains 'Stay safe Stay alert!'

- f. COVID-19 Grant Application: Crowle Colts. Resolved to authorise.
- g. Outcast Cricket Club. Confirmed £250 grant and with confirmation of new guidance from relative authority, additional funding if needed may be approved during the year. RFO to write to Outcasts to update them.
- h. Cemetery House Homecare Agreement. Council ruled that this was excessive cover and feel that local tradespersons should be approached for services when required. £4k is to be moved to the reserve account to offset future need.
- i. SSE Grant Money. An overpayment over previous years has been identified. SSE will pay the Council the adjusted figure to align the grant funding and the RFO is to move the banked overpayment into the correct account to resolve the matter.

No Arrow article is required at this time. Much support has been given to this Council from the Regen who produces their newsletter quarterly without charge. This Council unanimously agreed and resolved that a donation of £100 per issue towards the newsletter to help offset their costs.
