# F/127/20 Ward Report

Report provided by Cllr J Reed:

Library services are now available for people to go in and choose books and use the computers on Monday and Wednesday mornings from 0900 to 1200

Tuesday, Thursday and Friday from 0900 until 1200hrs close for lunch the reopen from 1300hrs until 16:30hrs

Some activities are now running in the upstairs of the Market Hall Yoga on Friday mornings also active Lincs class.

Adult learning will be coming in soon and heart rehabilitation is in the future plan.

The disability swim sessions have been well attended with families and will continue.

We have kept 1pm to 3pm Mon to Friday with a reduced gym capacity so that people who may be nervous about coming back, who were shielding, who have additional health complications, support from the GP referral staff and the NHS physio can attend and be assured that the centre will be quieter. These sessions can be booked by calling the centre.

Now that schools have returned, we have increased the number of lane swimming sessions available and we also have schools using the pool for their swimming lessons.

We could not re-start SwimLincs due to us not being able to run the classes with social distancing. However, we have just completed a 5-week swim course we put on as an interim offer and feedback has been good. The next course will start in a couple of weeks.

Our aquacise class was a popular one and was often at capacity, so we are now running two back-to-back on a <u>Wednesday morning</u> so more people can attend

Due to us being COVID safe, in the guidance issued yesterday leisure centres are still exempt from the 'rule of 6' guidelines so we can continue to operate as we are doing for now.

#### F/128/20 Feedback from External Meetings

<u>NATS</u>: Two main topics were covered; increasing crime and speeding. Crime rates have increased in the following areas: rural crime, general burglary and domestic violence. The police are focussing on these areas and speeding, particularly through Crowle and the A18. .

<u>Community Hall</u>: Plumbing works have commenced. No date of open can be notified at this time. COVID-19: A small local support system I still in place.
