- b. COVID-19.
 - i. Discussions on the safe opening of various venues and facilities are taking place. At present, playgrounds are to remain closed until further notice.
 - ii. NLC successfully received £32m grant allocation under the COVID-19 scheme, some of which was given to charities. The second wave of funding for businesses is shortly being released. Anyone that didn't receive funding can apply to NLC.
 - iii. Belton skip timings were questioned and comments will be taken to the appropriate cabinet officer.
- c. Appointment. Cllr J Reed will assume the new role of Children's/Families/Schools and Homeless cabinet officer.
