## 280/18 Minutes of the previous Schedule 12A meeting held on 31 October 2018

## 281/18 Leisure Centre Opening

Discussion regarding the conflicting information provided by NLC regarding the opening of the Leisure Centre was heard. Cllr J Dunn submitted electronic concerns to the Chair as his last minute nil attendance was unforeseeable. His points were:

- 1. Highlighted that our Ward Cllr should be supporting this Council and not battling against us.
- 2. That previous discussion regarding the blank cheques and moving of money is being highlighted again. This council needs to ensure that we are transparent and prove non-complicit otherwise he feels it looks like a cover up on our part.

Council debated the idea of producing a public statement regarding the insurance money – words to the effect of '£XX received as an insurance refund are now received and earmarked for the park refurbishments and chapel restoration'. Cllr D Middleton and TC to review this suggestion and inform Cllrs after legal advice sought.

Ian Horner, solicitor informed Cllrs D Middleton and E Dinsdale that unless statements are available and go public to support allegations of malicious actions that nothing can be done.
