254/18 RFO Change of Hours

Cllr E Dinsdale discussed the RFOs request for change of hours. She requested that her hours be reduced from 9 to 8 and moved to a full Tue and not 2 split days. 256/18 TC & RFO Grievance Letters

Cllr E Dinsdale read the grievance letters submitted by the TC and the RFO against Cllr J Reed. After seeking advice from ERNLLCA, Cllr E Dinsdale was advised to go straight to the Standards Board with these matters. NLC Said this was bad advice and wanted C&ETC to try agree with both parties to discuss the issues without the Standards Board. The TC and RFO met the Personnel Committee and agreed to hear Cllr Reed's response. Cllr Reed did not attend the meeting, instead Cllr E Dinsdale received Cllr Reed's resignation letter which he read to council.

Cllr E Dinsdale recommends after talking to the TC that it should now go straight to the Standards Board.

Cllr R Pender asks for this to be exactly minuted; "who the F@*k does Rob Waltham think he is?!". Cllr J Ramsden suggests getting Cllr Waltham to a meeting to ask what right he has to take our Mayor to task. Proposed by Cllr E

Dinsdale, seconded by ClIr M Bailey and unanimously agreed that it was decided to seek legal advice from the solicitor regarding ClIrs Reed and Waltham's accusations. It was also agreed that ClIr Waltham be asked to attend a meeting of C&ETC.
