# 72/18 Ward Report

NLC have now set the budget to provide services for residents and there will be a 3% social care precept and a 1.99% general precept increase

This will enable continued investment in Adult social care which is challenged by an especially long winter pressure, normally we would have seen a sizeable reduction in hospital admissions and release to care services by now. The community support teams have been working from 0800 to 2000hrs 7 days per week.

There is a new housing scheme under construction on Warwick Road Scunthorpe which will provide 20 apartments suitable for those living with Dementia and added on-site support and services

The concessionary travel scheme continues to be subsidised and call connect investment supported for another year.

Post 16 education bus passes are heavily subsidised with no increase cost to parents at £30 per annum

Disabled facilities grants, telecare and technology systems to support the disabled and older people stay in their own home longer and safer. Total investment over the next 5 years is over £5m

The Imagination Library which gives children such a good start with their reading skills is again supported

Roads and potholes see an extra £12m on the current budget and Cllr Briggs and I have driven around the ward to see where its most needed, please advise if there are any specific areas

Axholme Leisure project continues to progress and is expected to be open September. Tennis Courts and outside 9 x 9 all-weather pitch are completed. The top surface needs some wear before we can open to the public.

Heavy investment in LED Streetlights is making longer term savings in our energy bills and residents feedback to date has been positive on the new design.

Locally work continues on The Crowle Peatland Railway and visitor centre with a £100,000 ward investment

We are currently out for bidding for the next stage of The Isle Greenway which will connect the canal path up to Godnow/Medge Hall

Andrew, John and I continue to meet with Severn Trent and residents to push for the Crowle Scheme to be higher up the priority list and appeal for residents to contact us as well as Severn Trent so that we can make sure every incident is logged. We have had no internal flooding since 2013 but are still experiencing problems with people not being able to flush their toilet in heavy rainfall and tankers are on site again this week.

The new Crowle signs will be installed in the next couple of weeks. The intention is to put them directly behind the current planters so the flower arrangements can sit at the base.

The Cinema continues to be well attended and is now showing 2 films per month and a bi-monthly Saturday morning show. <a href="https://www.thecommunitycinema.co.uk">www.thecommunitycinema.co.uk</a> has details of all showings
