B/004/19 Mayors Report

B/006/19 Finance

B/007/19 Godnow Rd Parking

Parking along Godnow road, particularly from the Windsor Road entrance down to the Pavillion. This situation is extremely aggravated at the weekends when Crowle Colts are playing. Residents have complained that the drives are being blocked, verges being destroyed and vehicles being unable to pass. Council agreed that the TC would write to the Playing Field Committee to highlight these concerns. Proposed Cllr N Arrand, seconded Cllr J Ramsden and carried.

B/008/19 Parks

Ealand Park ropewalk quotes are being withdrawn by Playdale as they need to carry out a site visit to ascertain the damage. The proposed date is 4th Feb but will be confirmed by Playdale asap.

Manor Park requires a sign off inspection. Cllrs D Middleton, M Bailey & J Ramsden will meet Thu 24th Jan at 1400 hrs. Cllr D Middleton & J Ramsden will then move onto Ealand Park to review the latest works there.

Cllr R Pender proposed that the road surface at Manor Park entrance be quoted for repair. Seconded Cllr H Osborne and carried.

B/008/19 May 2019 Elections

Forms will be available from Feb./ TC to confirm if these can be held in the Council office. Member protocol forms were distributed for Cllr review. We will start advertising the Elections in Mar and place adverts in the Arrow, Regen news and local shops and noticeboards.

B/009/19 St Oswald's Church Clock

Update from Cllr M Bailey. Heritage funding and various others have absorbed the main bulk of the costs but they are short by an amount TBC. Should the works be carried out whilst the scaffolding is still in situ, the costs will be lower. Council informed that this organisation has received Council funding on a number of occasions in the past and legally, as a Council they cannot give money to the Church. As this item is not in quorum due to the cllr members DOIs decision cannot be made at this time and more information with an exact amount is needed.
