Manor Park anti-social/littering/foul language issues raised. TC to arrange a Community Police Team and schools meeting to discuss issues with children. Manor Park closure time will now be adjusted to 8:00pm.

F/020/22 Ward Report by Cllr Julie Reed

Isle Coaches have retired and routes picked up by Hornby's and Stagecoach. Just Go are still in service. Rail bus replacement remains in place until Dec.

Free swimming sessions will be available as normal throughout the summer holidays and the bus service for this will be £1 per child to allow accessibility for all areas/children.

The Summer Fuelled programme will be running as normal. Applicants can apply via the website or get in touch with Cllr J Reed.

The containers and domed building at Double Rivers has been reported to planning as response to residents' requests.

Brunyee Lane/Potts Lane rubble dumped by contractors has been reported.

Ward Cllrs have met with Riverside services regarding the level on service at local medical centers and are awaiting a response to the situation.

The waterboard meeting was attended by Cllrs Reed and Bint on 14 Jun 22. Disappointment was expressed and noted in relation to Wray's Drain which has not been actioned on time and will now delay the project by at least 6 months.

This comment relates to the implementation of an Investment Strategy for funds exceeding £100k. At the time, this council had reserve funds earmarked to complete a already procured project to refurbish Crowle Chapels which would reduce the funds under the required within a few months. The council wish write to the Internal Auditor to express this dissatisfaction of this comment, for a return letter of explanation and to also include a letter of explanation to accompany the AGAR and for public inspection. With this taken into account, council resolve to approve the Internal Audit Report.
