F/075/22 Ward Report by Cllr Julie Reed

In regard to the large silver building on J2 Estate I can advise that the operator has been informed that planning permission is required and they have confirmed that they will be submitting an application. In terms of the containers, they have confirmed that the containers are all empty and are simply being stored on the land for a temporary period. The intention is that the containers will be removed from the land by the end of the year and planning have advised they need to be removed by the end of 2022 and they will monitor this.

The Fuelled program which is the healthy food and activity program that Government provided funding for has run through the summer with 45 activity providers plus direct delivery by North Lincs Council, over 12000 placements were on offer, and it was great to see our kids at Axholme North Sports Hall joining in. Children and families have both been positive in their feedback and I am pleased to advise that we are working on Christmas holidays now.

The summer free swimming sessions "Summer Daze" was successful with 458 attendances from 25th July to 4th September at Axholme North Leisure Centre and 6730 across the county.

Cllr John Briggs and I again requested information on the Isle of Axholme Drainage Board at the meeting earlier today on the situation with Wrays Drain and understand the final technical queries and acquisition of permission from the landowner are still ongoing but progressing well so we await confirmation of the start date. As you know this must be done before we can progress the Godnow Road scheme

We have requested that the graffiti on the 5G mast cabinet at the top of Ealand be dealt with and repainted and requested that it be green to better blend in with the existing cabinets.

The Maple Avenue planning application that was of significant public interest was refused at planning committee

Northern Trains advise that they will be returning to service stopping at Crowle on December 11th with a 2 hourly service.

In Bloom 2023 applications are invited with a deadline of 12th November

Planning permission has been granted for the electric roller shutter and a request for variation has been submitted and approved by SSE there is no cost to the Council

F/079/22 Option to Opt Out of the SAAA Central External Auditor Appointment Arrangements

The council discussed the following:

Under the Local Audit (Smaller Authorities) Regulations 2015, SAAA is responsible for appointing external auditors to all applicable opted-in smaller authorities, for setting the terms of appointment for limited assurance reviews and for managing the contracts with the appointed audit firms. Smaller authorities are those whose gross annual income or expenditure is **less than £6.5 million**.

The next 5-year appointing period runs from 2022-23 until 2026-27 and SAAA has undertaken a procurement exercise to appoint auditors to each County area from 1 April 2022. Now that the submission deadline for the 2021-22 Annual Governance and Accountability Returns has passed, this is to advise you of the option to opt-out of the next round of 5-year audit appointments

Council RESOLVED to remain opted-in to the scheme.

Cllr J Ramsden highlighted the speed variations and their placement and the impact on traffic and frequent accidents/near misses. He proposed the removal of the 50mph speed entirely, the relocation of the 30mph sign to the south of the Outgate entrance.

TC instructed to invite Mr Jonathan Lillicrap to meet with Cllr J Ramsden to discuss this road and a speed review and request advice on getting our residents to report near misses/accidents to this department.

TC to put out a residents plea onto social media to request anyone that has any issues on this road to report to NLC so a full profile report can be observed and support a case for highway improvement.
