Action was taken by Funeral Directors which has resulted in a new sub-contractor taking on grave digging duties within Crowle Cemetery. All dealings with this sub-contractor have been positive, the standard of work and interaction has been of impeccably high standards and no further complaints or concerns have been raised. **NOTED**. Council demand that all practices and procedures are up to standard and that all paperwork is to be provided for any sub-contractors to work within Crowle Cemetery at all times.

The Cemetery Management Policy will be further reviewed and brought back to the next meeting included a new separate pricing structure.
